With your DocuBank Card, hospitals and doctors can obtain your directives immediately from DocuBank via fax or the internet – using just the member number, PIN, and instructions on your card. You will also receive alert stickers for your driver's license and health insurance card to make hospital staff aware of your DocuBank registration.

Immediate Access to Your Medical Information

Your Emergency Card displays life-saving medical information – your allergies and important medical conditions – so emergency staff can give you the most appropriate treatment without delay. You can also have DocuBank provide a list of your current medications along with your directives, for a small additional fee.

Alerting Your Loved Ones

When hospital staff request your healthcare directives from DocuBank, they will also receive the names and phone numbers of your doctor and up to three loved ones, so that the hospital can reach them quickly in an emergency. Additionally, the name of your primary emergency contact and relevant phone numbers appear right on your card for quick access.
